

Environment Policy

Introduction.

Environmental Objectives

Forza Doors sets long-term environmental goals to improve our performance and reduce our carbon emissions. We will adopt achievable objectives and create action plans for their completion in relation to our environmental impact. We strive to:

- Achieve net-zero carbon emissions by 2050 covering all scopes 1,2 and 3 carbon emissions. In line
 with our purpose to contribute to a safe and liveable world, we recognise that companies play a
 significant role in the reduction of global Green House Gas emissions.
